

(Current Report No 062/2013)**November, 18th 2013****Notification given pursuant to Art. 160 of the Act on Trading in Financial instruments.**

Legal basis: Art. 160.4 of the Act on Trading - information about transactions effected by persons having access to confidential information

The Management Board of LC Corp S.A. (the Issuer) reports that the Company received a notification, pursuant to Art. 160 of the Act on Trading in Financial Instruments, from Mr Remigiusz Baliński, Member of LC Corp S.A. Supervisory Board, who reported that a legal person - closely related to him (pursuant to Art. 160 of the Act), i.e. Noble Securities S.A. of Kraków in which Mr Remigiusz Baliński is Vice-chairman of the Supervisory Board – made the following transactions concerning LC Corp S.A. shares between 8 and 13 November 2013:

- the disposal of 6,500 shares of LC Corp S.A. on 8 November 2013 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.94 per share
- the acquisition of 6,500 shares of LC Corp S.A. on 8 November 2013 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.91 per share
- the acquisition of 2,895 shares of LC Corp S.A. on 12 November 2013 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.87 per share
- the disposal of 5,500 shares of LC Corp S.A. on 12 November 2013 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.91 per share
- the disposal of 14,222 shares of LC Corp S.A. on 13 November 2013 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.82 per share
- the acquisition of 17,593 shares of LC Corp S.A. on 13 November 2013 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.83 per share.
