

Information of Management Board of LC Corp S.A.

The Management Board of LC Corp S.A., relying on the Declaration of the Supervisory Board, informs that an audit firm responsible for the examination of both the separate and consolidated annual financial statements for the financial year 2018 has been elected in compliance with rules and regulations, including with those relating to the selection of audit firms and a procedure for selecting the same. The Management Board of LC Corp S.A. further informs that pursuant to the Declaration of the Supervisory Board:

- a) The audit firm and members of auditing team have satisfied conditions for compiling an impartial and independent report concerning the audit of the separate and consolidated annual financial statements for the financial year 2018 in compliance with rules and regulations in force and applicable professional standards and principles of professional ethics;
- b) Applicable rules and regulations on the rotation of audit firm and the key statutory auditor and mandatory cooling-off periods are complied with;
- c) The issuer has adopted a policy regarding the selection of an audit firm and a policy concerning the provision to the issuer by an audit firm, an undertaking related to an audit firm or a member of its network providing additional services other than audit, including services which have been conditionally exempt from a ban on provision by an audit firm.
