

## **(Current Report No 074/2015)**

### **Notification given pursuant to Art. 160 of the Act on Trading in Financial Instruments.**

Legal basis: Art. 160.4 of the Act on Trading - information about transactions effected by persons having access to confidential information

The Management Board of LC Corp S.A. (the "Issuer") reports that the Company received two notifications, pursuant to Art. 160 of the Act on Trading in Financial Instruments, from Mr Remigiusz Baliński, Member of the Issuer's Supervisory Board, who reported that a legal person - closely related to him (pursuant to Art. 160 of the Act), i.e. Noble Securities S.A. of Warsaw in which Mr Remigiusz Baliński is Vice-chairman of the Supervisory Board, made the following transactions in the period between 28 August 2015 and 3 September 2015:

- the disposal of 1,000 shares of LC Corp S.A. on 28 August 2015 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.85 per share;
- the disposal of 4,000 shares of LC Corp S.A. on 31 August 2015 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.88 per share;
- the acquisition of 5,000 shares of LC Corp S.A. on 31 August 2015 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.85 per share;
- the acquisition of 1,000 shares of LC Corp S.A. on 2 September 2015 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.83 per share;
- the disposal of 2,226 shares of LC Corp S.A. on 2 September 2015 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.86 per share;
- the disposal of 4,230 shares of LC Corp S.A. on 3 September 2015 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.90 per share;
- the acquisition of 1,000 shares of LC Corp S.A. on 3 September 2015 as a result of a transaction made in the ordinary session mode at the Warsaw Stock Exchange, at an average price of PLN 1.90 per share.

The above-mentioned transactions were effected as part of the Issuer's Market Maker activities performed by Noble Securities S.A. for LC Corp S.A.
